Each bidder file remains valid for its author for a period of 60 days from the deadline for submission of bids. 7. A shortlist of service providers/suppliers per market will be drawn up following the call for expressions of interest and the consultation will be carried out in accordance with HI's Rules of Procedure. Framework contracts will be signed with the selected service providers/suppliers.

 - o Certificate of Registration or Certificated of incorporation from the Registrar of Company
 - o Certificate of Business Registration
 - o NRA registration & proof of payment
 - o NASSIT registration & proof of payment

 - o ID Card of the contact person and/or business owner as per Business Registration
 - o Contact details of at least three (02) professional references

The purpose of this call for EOI is to identify appropriate vendors and service providers who could be selected to make proposals to HI; it does not constitute an invitation to tender. Only companies deemed qualified by HI, after compliance approval, will receive the invitation to quote.

HI is the sole judge as to the preselection of the service providers.

The selected individuals/companies will sign the following HI Policies, that will also be in an integral part of the framework contract: Child protection, Anti-fraud Bribery and corruption, Conflict of Interest and Sexual exploitation, abuse and Harassment.
